Samuel Wambayo, Kids Club Kampala

Samuel Wambayo is the Founder and Executive Director of Kids Club Kampala, a charity working with at-risk children and empowering communities in Uganda. Sam is also the founder and coordinator of the Ewafe Project for Abandoned Children. He is a member of Child Inclusive Mediation and Counselling (Australia) which gives free mentorship and consultancy to young NGOs, as well as an active Rotarian. Samuel has a background in strategic management and was born, has lived, and is now at the forefront of fighting child poverty in Uganda.

Gideon Rabinowitz, Bond

Gideon joined Bond in July as their new Director of Policy and Advocacy following his work as Senior Manager at Agulhas Applied Knowledge, where he has led reviews for the Independent Commission for Aid Impact (ICAI) and major consultancy and research projects for clients including the African Development Bank, the UN and several bilateral agencies. Dr Waradas Thiyagaraja, University of Bath

Waradas is a peace and conflict studies scholar with particular focus on the intersection between sexual and gender justice movements and identities and armed conflict and post-war transitions. His research work includes conflict negotiations, peacebuilding and queering transitional justice in Sri Lanka. He spends time organizing marginalized segments of the LGBTIQA+ communities in Sri Lanka to decentralize the sexual and gender justice landscape. Waradas is also a professional language interpreter in Sinhala, Tamil and English.

Anuradha Kowtha, The Kowtha Constellation

Anuradha, a neurodivergent, disabled, queer person of South Indian heritage, is a speaker, strategist and founder of The Kowtha Constellation. In their work, Anuradha owns and runs The Kowtha Constellation, where we can help you build equitable, inclusive, and accessible practices into your organizational systems so you can sustainably obtain funding, challenge perceptions of bias, and adhere to compliance and accessibility requirements. Andrew Mitchell, Minister of State (FCDO) (Development and Africa)

Andrew Mitchell was appointed as a Minister of State in the Foreign, Commonwealth & Development Office (FCDO) on 25 October 2022. He was previously Secretary of State for International Development from May 2010 to September 2012. He was elected Conservative MP for Sutton Coldfield on 7 June 2001. Andrew was educated at Rugby School and Jesus College, Cambridge where he studied history and was President of the Union. He served in the Royal Tank Regiment before joining Lazard, where he worked with British companies seeking large-scale overseas contracts. After serving as a government whip between 1993 and 1995, Andrew served as Minister for Social Security from 1995 to 1997. While in opposition, he was Shadow Minister for Economic Affairs from 2003 to 2004 and Shadow Minister for Home Affairs from 2004 to 2005. He then served as Shadow Secretary of State for International Development until the 2010 election. Andrew is married with 2 children.

Adrian Lovett, Development Initiatives

Adrian Lovett is Chief Executive Officer of Development Initiatives, previously serving as President and CEO of the World Wide Web Foundation for five years. Adrian was also a commissioner on the UN Broadband Commission and Co-chair of the World Economic Forum Council on the Connected World during this time. He previously held leadership roles at ONE, Oxfam and Save the Children, as well as Make Poverty History and the Jubilee 2000 'Drop the Debt' campaign. Development Initiatives are a founding member of SWIDN and we are grateful to Adrian for chairing the Q&A session on behalf of all our members.
